# Chinese astronauts return to Earth after vessel damaged by space debris

BEIJING : (AGENCY)

Three Chinese astronauts whose return to Earth was delayed by space debris hitting their vessel last week landed in China on Friday afternoon, according to state broadcaster CCTV. China Manned Space Agency (CMSA) revealed details about the debris damage for the first time on Friday, saying "tiny cracks" were found in a small window of the Shenzhou-20 spacecraft's return capsule. "The capsule does not meet the safety requirements for a crewed return, Shenzhou-20 will remain in orbit and conduct relevant experiments," the agency said in a statement. The astronauts were due to return to Earth nine days ago after completing a six-month mission on China's permanently inhabited Tiangong space station, a programme known as Shenzhou, or "Divine Vessel", when the crack was discovered. The crew left Tiangong on another spacecraft, the Shenzhou-21,



according to CMSA, touching down at the Dongfeng landing site in north China's Inner Mongolia Autonomous Region at 4:40 p.m. (0840 GMT). The mission began in April and went smoothly until the debris incident forced the Shenzhou-20's return, originally scheduled for November 5, to be postponed, CMSA said. The delay,

while only nine days, was highly unusual for a programme that had run like clockwork and in the past year reached new milestones, with the deployment of astronauts born in the 1990s, a world-record spacewalk and plans to send the first foreign astronaut, from Pakistan, to Tiangong next year. Every Shenzhou mission on the

return to Earth nine days ago after completing a six-month mission on China's permanently inhabited Tiangong space station, a programme known as Shenzhou, or "Divine Vessel", when the crack was discovered.

Tiangong ends with a handover, where the departing crew welcomes the arriving crew that will take over the space station's operations. During the handover period of several days, two Shenzhou vessels are docked at the space station. China's manned space programme now has to deal with another logistical headache - how to get the space station's newly arrived crew home in the event of an emergency. The Shenzhou-21 spacecraft and its three-person crew arrived at Tiangong two weeks ago. But with the departure of the Shenzhou-20 crew on the Shenzhou-

21 vessel, the Chinese space station is currently without a flightworthy vessel, meaning the Shenzhou-21 crew currently living there is stuck in space until a replacement vehicle arrives. According to China's safety protocols, when astronauts cannot be safely flown back to Earth due to a malfunction, an unmanned emergency rescue spacecraft will be launched from the ground to take the astronauts back to the ground. CMSA said the Shenzhou-22 spacecraft would be launched at "an appropriate time in the future". The damage to the Chinese spacecraft highlights the growing challenge of "space junk" to space exploration. "Due to the sharp increase in orbital debris, the likelihood of damage to spacecraft and space stations of all countries has risen significantly," Igor Marinin, a member of the Russian Academy of Cosmonautics in Moscow, told Reuters. While this is the first known debris disruption for a Shenzhou mission, junk in space has ensnared past missions to the International Space Station, the 25-year-old science lab led by the United States.

# US labels four European Antifa-linked groups as global terrorists, expands crackdown

WASHINGTON : (AGENCY)

The United States has named four European groups linked to Antifa as "specially designated global terrorists," expanding the Trump administration's crackdown on left-wing extremist organisations. The move places the groups under sanctions, with the US also planning to list them as foreign terrorist organisations from November 20. In a statement, the US State Department said it is "designating German-based Antifa Ost, along with three other violent Antifa groups in Italy and Greece, as Specially Designated Global Terrorists and intends to designate all four groups as Foreign Terrorist Organizations, effective November 20, 2025." These groups have been involved in violent attacks across Europe, often targeting government buildings, right-wing political offices, or institutions they consider symbols of capitalism. Some groups have also claimed to act in solidarity with Palestinian movements. The State Department cautioned that American citizens or businesses engaging with

the named organisations could face consequences. "Persons that engage in certain transactions or activities with those designated today may expose themselves to sanctions risk," it said, adding that there is



also a risk of secondary sanctions under counterterrorism laws. The department said the decision supports President Donald Trump's push to dismantle Antifa-linked networks. It noted that "The designation of Antifa Ost and other violent Antifa groups supports President Trump's National Security Presidential Memorandum-7, an initiative to disrupt self-described 'anti-fascism' networks, entities, and organisations that use political violence and terroristic acts to undermine democratic institutions, constitutional rights, and fundamental liberties." The latest action is

part of Trump's broader effort to clamp down on antifa, which he has repeatedly accused of fuelling violent unrest in the United States. He has previously issued an executive order describing antifa as a domestic terrorist organisation. According to the State Department, the terror designation will help "expose and isolate entities and individuals, denying them access to the US financial system and resources they need to carry out attacks." In September, US President Donald Trump issued an executive order announcing that he would designate the far-left, anti-fascist movement Antifa as a "major terrorist organisation."

# उत्तर प्रदेश मंत्रिपरिषद ने दिल्ली बम विस्फोट की निंदा की

उत्तर प्रदेश मंत्रिपरिषद ने दिल्ली बम विस्फोट की निंदा करते हुए शुक्रवार को एक प्रस्ताव पारित किया और इस हमले को कायाना कृत्य करार दिया। मंत्रिपरिषद ने इसके साथ ही 20 प्रस्तावों को मंजूरी दी जिनमें भारतीय महिला क्रिकेट टीम और ऑलराउंडर दीप्ति शर्मा को उनकी हालिया उपलब्धियों के लिए बधाई देने वाला प्रस्ताव भी शामिल है।

उत्तर प्रदेश के कैबिनेट मंत्री सुरेश खन्ना ने शुक्रवार को राज्य मंत्रिमंडल की बैठक में लिए गए प्रमुख निर्णयों की जानकारी पत्रकारों को दी। मुख्यमंत्री योगी आदित्यनाथ की अध्यक्षता में हुई उत्तर प्रदेश कैबिनेट की बैठक में भारतीय महिला क्रिकेट टीम को वनडे विश्वकप में मिली ऐतिहासिक जीत पर बधाई दी गई।

बैठक में टीम के जज्बे, अनुशासन और शानदार प्रदर्शन की सराहना करते हुए कहा गया कि खिलाड़ियों ने देश का गौरव बढ़ाया है। वित्त मंत्री सुरेश खन्ना ने कहा कि यह जीत न केवल भारतीय क्रिकेट के लिए गर्व का क्षण है बल्कि देश की युवा बेटियों के लिए प्रेरणा का भी स्रोत है। प्रदेश कैबिनेट ने दिल्ली में हाल ही में हुई आतंकी घटना की कड़ी निंदा की है। बैठक में कहा गया कि यह घटना देश की शांति और सुरक्षा पर हमला है। मुख्यमंत्री और कैबिनेट ने हमले में मारे गए और घायल हुए लोगों के परिजनों के प्रति गहरी संवेदना व्यक्त की।

एक बयान के मुताबिक उत्तर प्रदेश कैबिनेट ने राज्य में बुद्धवस्था पेंशन को लेकर एक बड़ा निर्णय लिया है। अब पात्र वरिष्ठ नागरिकों को पेंशन के लिए अलग से आवेदन करने की आवश्यकता नहीं होगी। समाज

कल्याण मंत्री (स्वतंत्र प्रभार) असीम अरुण ने बताया कि फैमिली आईडी 'एक परिवार-एक पहचान' प्रणाली से पात्र लाभार्थियों का स्वतः चिह्निकरण होगा और उनकी सहमति मिलने पर पेंशन सीधे स्वीकृत की जाएगी। वर्तमान में 67.50 लाख वरिष्ठ नागरिक इस योजना का लाभ ले रहे हैं, लेकिन बड़ी संख्या में ऐसे लोग भी हैं जो प्रक्रिया पूरी न कर पाने के कारण पेंशन से बाहर रह जाते हैं। नया फैसला इसी समस्या को हल करने पर केंद्रित है। उन्होंने बताया कि सहमति मिलने के बाद योजना अधिकारी 15 दिनों के भीतर डिजिटल सिग्नेचर के माध्यम से पेंशन स्वीकृत करेंगे और स्वीकृत पत्र लाभार्थी को डाक से भेजा जाएगा। उन्होंने बताया कि भुगतान सीधे आधार-लिंकड बैंक खाते में किया जाएगा और हर किस्त की जानकारी एसएमएस द्वारा उपलब्ध होगी। उन्होंने बताया कि सरकार एक मोबाइल ऐप भी उपलब्ध कराएगी जिसमें लाभार्थी पासबुक की तरह अपने सभी भुगतान देख सकेंगे। प्रदेश सरकार ने राज्य में किरायेदारी को

सरल और पारदर्शी बनाने के लिए भी बड़ा फैसला लिया है। कैबिनेट ने 10 वर्ष तक की अवधि के किरायानामा विलेखों पर स्टाम्प शुल्क और रजिस्ट्रेशन फीस में छूट मंजूर कर दी है। इसका उद्देश्य यह है कि भवन स्वामी और किरायेदार दोनों किरायानामा लिखित रूप में तैयार करें और रजिस्ट्री कराएं, जिससे विवाद कम हों और किरायेदारी विनियमन अधिनियम का प्रभावी क्रियान्वयन हो सके। वित्त मंत्री सुरेश खन्ना ने बताया कि वर्तमान नियमों के अनुसार एक वर्ष से अधिक अवधि की किरायेदारी विलेख की रजिस्ट्री अनिवार्य है, लेकिन आमतौर पर अधिकांश किरायानामा मौखिक होते हैं या यदि लिखित होते भी हैं तो उनकी रजिस्ट्री नहीं कराई जाती।

प्रदेश कैबिनेट ने दुकान और वाणिज्य अधिष्ठान अधिनियम 1962 में महत्वपूर्ण संशोधन को मंजूरी देते हुए इसकी सीमा नगरीय क्षेत्रों से बढ़ाकर पूरे प्रदेश तक कर दी है। अब राज्य के सभी जिलों और ग्रामीण क्षेत्रों

के प्रतिष्ठान भी इस कानून के दायरे में आएंगे। इससे अधिकतम श्रमिक कानूनी संरक्षण के दायरे में आएंगे और उनके अधिकारों की रक्षा सुनिश्चित होगी। श्रम मंत्री अनिल राजभर ने बताया कि संशोधन के तहत यह अधिनियम अब उन प्रतिष्ठानों पर लागू होगा जिनमें 20 या उससे अधिक कर्मकार कार्यरत हैं। इससे छोटे प्रतिष्ठान बिना अतिरिक्त बोझ के अपनी आर्थिक गतिविधि को सुचारू रख सकेंगे, जबकि बड़े प्रतिष्ठानों में कार्यरत कर्मचारियों को अधिनियम के तहत मिलने वाले सभी लाभ मिलेंगे। सरकार का मानना है कि इससे प्रदेश में व्यापारिक गतिविधियां और तेज होंगी। कैबिनेट ने लेखपाल सेवा नियमों में बड़ा बदलाव करते हुए चैनल के लिए लेखपाल पद पर पदोन्नति का मार्ग खोल दिया है। खन्ना ने बताया कि पंचम संशोधन नियमावली 2025 के तहत अब लेखपाल के कुल पदों में से दो प्रतिशत पद योग्य चैनल में पदोन्नति के आधार पर दिए जा सकेंगे।
